

ONLINE PRIVACY POLICY AGREEMENT

Nonprofit Board Crisis, is committed to keeping any and all personal information collected of those individuals that visit our website and make use of our on-line facilities and services accurate, confidential, secure and private. Our privacy policy has been designed and created to ensure those affiliated with Nonprofit Board Crisis of our commitment and realization of our obligation not only to meet but to exceed most existing privacy standards.

Collection of Information

Nonprofit Board Crisis may disclose your personal information, without prior notice to you, only if required to do so pursuant to applicable laws and/or in a good faith belief that such action is deemed necessary or required to:

- a) Conform to decrees, laws and/or statutes or in an effort to comply with any process which may be served upon Nonprofit Board Crisis and/or its website;
- b) Safeguard and/or preserve all the rights and/or property of Nonprofit Board Crisis; and
- c) Perform under demanding conditions in an effort to safeguard the personal safety of users of nonprofitboardcrisis.typepad.com and/or the general public.

Children Under Age of 13

Nonprofit Board Crisis does not knowingly collect personal identifiable information from children under the age of thirteen (13) without verifiable parental consent.
